03. Health Certificate, issued by the Competent Authority.
04. Permanent Resident Certificate.
05. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.


The appointment shall be subject to the following conditions :-

- (a) If, on verification, the certificate(s) produced by the appointee is/are proved fake or forged, the appointment shall be cancelled abinitio.
- (b) The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police, CID, Jammu and Kashmir to whom a reference shall be made by the Department, his appointment shall deem to be cancelled ab-initio and he shall have no claim on his appointment.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.

The appointee shall be initially on probation for a period of two years.
