Subject: Seniority list of non-gazetted employees of Jammu division as on 01-01-2017

Whereas the final seniority list of the employees of Jammu division was issued in the year 2010 vide Director Handloom Development Department's Order No. DHD/135 of 2010 dated 13-12-2010.

Whereas the undersigned vide Director Handloom Development Department, J&K, Srinagar's office letter No. DHD/Esstt/2449/694, dated 01-08-2017 was asked to circulate the tentative seniority lists in Jammu division for obtaining the objections, if any, from the employees so that final seniority list is issued.

Whereas the tentative seniority list of the non-gazetted employees of Jammu division was circulated to all the Assistant Directors of Handloom Development Deptt. of Jammu division vide this office's letter No. JDHJ/260-P/961-71, dated 9-8-2017 and was published in leading newspapers of Jammu division for obtaining objections, if any, to the tentative seniority list of non-gazetted employees of Jammu division. A time period of 21 days was given.

Whereas the following objections/representations were received to the tentative seniority lists and disposed thereof:-

- a) Smt. Vippin Kumari W-c-W had requested for including 10+2 as her qualification for which she submitted her marks certificate issued by JKBOSE. The same stands included in the final seniority list subject to the verification from JKBOSE.
- b) Sh. Dileep Kumar, Junior Assistant had requested for including Quasi Permanent and RBA category against his category and submitted the copy of Directorate of Handloom Dev. Deptt. Order No. DHD/86 of 2014 dated 19-11-2014 and RBA category certificate issued on 25-11-2005. The official has been declared Quasi Permanent and the same has been included in the seniority lists. However the RBA certificate submitted by the official was valid for five years i.e. upto 25-11-2010 and

Therefore the same was not included in the seniority lists. He had also submitted that he has passed Secretariat Assistant Training Course of Departmental Examination session April 2016 for which he had submitted copy of Notification No. Dated 29-11-2016 and necessary inclusion has been made in the final Seniority list.

c) Sh. Devinder Singh, Junior Assistant had submitted Diploma in Management of Indl. Coop. from ICM, Chandigarh and Higher Diploma in Cooperative Management to be included as his qualification. Since the official was sent for undergoing the training by the Directorate Handloom Dev. Deptt.'s letter No.DHD/STS/52-II/91-92/3831-35 dated 26-11-1992, the same stands incorporated in the final seniority list.

d) Sh. Ashish Sharma Junior Assistant had submitted copy of his Master Degree in Economics for inclusion in his qualification in the seniority list. The same stands incorporated subject to the verification from IGNOU.

Whereas Sh. Javed Iqbal Head Weaver had requested that he had done Weaving Training course from UNDP and Indian Institute of Handloom Technology, Chowkaghat, Varanasi on the recommendation of Department of Handloom Dev. Though the same was not pleaded within 21 days of filing the objections, the same was also given consideration in the final seniority list of Head Weavers.

In light of the above and in compliance of the instructions issued vide Director Handloom Dev. Deptt.'s letter No. DHD/Estt/Meeting/2017/3017 dated 24-11-2017, the final seniority list of Divisional and District level non-gazetted employees of Jammu division as on 01-01-2017 is hereby issued as per Annexure A for information of all concerned.
